



2024 JUNIOR PROGRESSIVE BREEDER AWARD

REQUIREMENTS:

1. Junior Member(s) applying for an award must be a breeder of the animal. The breeder of an animal will be determined as stated on the registration certificate. The animal does not have to be presently owned by the junior member(s) making application. Applicant must have owned the dam of the animal entered at the time of conception. If animal is bred and owned by multiple parties, all parties must have been junior members at the time of breeding.
2. Applicant must not have passed their 21st birthday as of January 1st of the year of submitting the application (those that turn 21 during the project year are eligible to apply for this award).
3. Breeder (applicant) must be a junior member of the Wisconsin Holstein Association by August 15th of the year in which this award was submitted.
4. Junior members may submit as many animals as qualify for this award.
5. Only the latest completed **305d** (or less) production records and **current** classification score will be considered.
6. Animals must have the following production records and current classification score to be considered. (Minimum requirements)

* Milking Yearling	19,500 lbs. M	Classified GP-82
* 2 Year Old	20,500 lbs. M	Classified GP-83
* 3 Year Old	22,500 lbs. M	Classified GP-84
* 4 Year Old	24,000 lbs. M	Classified VG-85
* 5 Year Old	25,000 lbs. M	Classified VG-86
* 6 Year Old & Over	26,000 lbs. M	Classified VG-87
7. Applicants **MUST SUBMIT a copy** of this animal's registry certificate with the classification posted, and an official BAA print out of traits or pedigree if the registration paper is not stamped. A pedigree, official test sheet or individual cow report is also **required** to verify production.
